## Termination in the Twenty-First Century

The concept of termination as a phase of analysis has evolved a great deal since Freud introduced it in his 1937 paper, Analysis, Terminable and Interminable. From the middle to late 20<sup>th</sup> century, termination was idealized by many. More recently, in recognition of the fact that ideal termination rarely occurs, analysts have studied and accepted many kinds of terminations, in an effort to make analysis more flexible to fit the patient and to optimize the outcome of the treatment across the spectrum of ways of terminating.

*Michael Gundle is a training and supervising analyst at the Seattle Psychoanalytic Society and Institute, where he is former Faculty Chair and former Director. He has held various positions in the American Psychoanalytic Association and is the current liaison from the IPA to the Taiwan Center for the Development of Psychoanalysis. Dr. Gundle has taught courses in Seattle, Portland, Vancouver and Taipei. He is Clinical Associate Professor of Psychiatry at the University of Washington. He is in private practice in Seattle.*
